A. FEE CREDIT MODEL FOR EXCHANGE FEES

- As announced previously, CME Group is transitioning to a fee credit model for Exchange Fee discounts, to create an itemized statement for the client, rather than embedding discounts within the rate and the total fees applied.
- All incentives that are calculated within the Exchange Fee System (EFS) have been converted to this model. Therefore, all discounts are now delineated by 'Discount Description' on the **Fee Discounts Report** for each Exchange.
