Member does not include employees, associated persons, affiliate companies, subsidiary corporations or parent corporations of such member firm unless they also own a membership.

*Exchange contract fees are show on a "per side" basis and are applicable to exchange for physical (EFP); exchange for rick (EFR); delivery of futures; and exercised, expired or assigned options contracts. Exchange fees are not applicable to transfer trades.

Exchange Fee/Clearing Fee waiver for CBOT and CME members for KCBT Wheat future/options and MGEX-KCBT Spread Options Pit Trades, Pit Spreads and Pit Give Ups only from July 1, 2013 - November 30, 2013.

Note 3. Product Seat Division Eligibility -

Futures: Account Owners must hold or lease a CBOT FULL or CME seat to be eligible for reduced rates.

Options: Account Owners must hold or lease a CBOT FULL, AM , COM , CME , IMM or IOM seat to be eligible for reduced rates.
