#### **INTEREST RATES**

- Treasury options traded over 511,000 contracts a day in Q1, up 42% YoY.
- A record 54% of all treasury options traded electronically on CME Globex in Q1, with a record 59% of 10-Year note options trading on CME Globex in March.
- Weekly Treasury options traded 1.6 million contracts in Q1'13 up 43% over Q1'12.
- 5 Year Purple Mid Curves traded over 34,000 contracts in their first month of trading with OI over 30,000.



#### **EQUITY INDEX**

- Equity index options traded averaged 308,984 contracts a day during Q1, up 69% vs. Q1'12.
- Equity index options reached an all-time Open Interest record of 3.86 million contracts on March 14th. E-mini S&P 500 options also set record open interest of 3.1 million.
- 63% of S&P 500 options (standard and e-mini) traded electronically in O1.
- E-mini S&P 500 weekly options averaged 53,440 contracts a day, up 133% over Q1'12
- Weekly options representing 19% of the E-mini S&P 500 options volume for the quarter.



#### **ENERGY**

- Energy options volume was up 15% from Q4'12, averaging over 260,000 contracts per day.
- Electronic options volume was 24% of total options volume, up from 14% one year earlier.
- 35% of Crude Oil options were traded on CME Globex, up 12% from Q4 and up 30% YoY.
- Henry Hub Natural Gas options volume on CME Globex increased 45% YoY.
  WTI-Brent Crude Oil Spread options (BV) volume increased



#### FX

- CME FX options averaged 64,000 contracts a day in Q1 (8.2 billion notional a day), up 72% YoY.
- CME FX options volumes have increased in all of our major currencies YoY: EUR +27%, JPY +179%, AUD +44%, GBP +245%, CAD +82%, CHF +56%.
- A Record 86% of CME FX options have been traded electronically YTD, up from 78% from 2012.
- Weekly FX options volume in growing strongly with ADV of 5,720 contracts, up 585% YoY.



#### **AGRICULTURE**

- Electronically traded agricultural options have increased by 54% since Q1'12. Agricultural options volume is up 2% during that time period.
- Open interest in Short-Dated New Crop options has surpassed 100,000 and year to date volume is more than 102,000 contracts.
- Weekly Grain options have traded more than 1.1 million contracts since their launch in 2011.



# **METALS**

- Metals options volume was up 32% from Q4'12, averaging over 49,000 contracts per day.
- Electronic options volume was 52% of total options volume, up from 42% from one year earlier.
- Gold options traded on CME Globex were up 21% from Q4 and up 47% YoY.
- Electronic Copper options volume on CME Globex grew 169% from O4 and 547% YoY.
