Column 1 - MTH/STRIKE - The Month column designates the month and year of the contract.

Column 2 – Open - represents the first price at which the contract traded after opening, on either Globex or Open Outcry.

Column 3 – High - displays the highest price at which the contract traded during the trading day, during either Globex or the Open Outcry session. If the price is followed by a "B", this indicates a bid price that was higher than the highest traded price.

Column 4 – Low - displays the lowest price at which the contract traded during the trading day, during either Globex or the Open Outcry session. If the price is followed by an "A", this indicates an ask price that was lower than the lowest traded price.

Column 5 – Last - displays the last price traded in Open Outcry. If the last price is followed by a "B" or an "A", this indicates that the last price was a bid or ask.

Column 6 – Sett - Displays the settlement price calculated at the end of the trading day for the contract.

Column 7 – CHGE – displays the change in price between the trade date settlement price and the previous day's settlement price. If the current day's settlement price is the same as the previous day's price, or if the previous trading day was the first day the product was settled, UNCH is displayed.

Column 8 – EST. VOL –displays the total number of contracts traded during the trading day, during both Globex and the Open Outcry session. A dash in this column indicates that the contract did not trade on the trade date.

Column 9 – SETT – Prior Day Settlement displays the final settlement price calculated at the end of the previous trading day.

Column 10 – VOL – Prior Day Volume displays the total number of contracts traded during the prior day trading. Both outright and spread volume is included. A dash in this column indicates that the contract did not trade on the trade date.

Column 11 – INT – The Open Interest column displays the total number of contracts long or short in the respective month, during both Globex and the Open Outcry session. Each open transaction has both a buyer and seller, but only one side of the transaction is counted when calculating open interest.

OPTION – Title includes product name, contract month and type

Column 1 - MTH/STRIKE - displays the strike price of the option.

Column 2 – Open - represents the first price at which the contract traded after opening, on either Globex or Open Outcry.

Column 3 – High - displays the highest price at which the contract traded during the trading day, during either Globex or the Open Outcry session. If the price is followed by a "B", this indicates a bid price that was higher than the highest traded price.

Column 4 – Low - displays the lowest price at which the contract traded during the trading day, during either Globex or the Open Outcry session. If the price is followed by an "A", this indicates an ask price that was lower than the lowest traded price.

Column 5 – Last - displays the last price traded in Open Outcry. If the last price is followed by a "B" or an "A", this indicates that the last price was a bid or ask.

Column 6 – Sett - Displays the settlement price calculated at the end of the trading day for the contract.

Column 7 – CHGE – displays the change in price between the trade date settlement price and the previous day's settlement price. If the current day's settlement price is the same as the previous day's price, or if the previous trading day was the first day the product was settled, UNCH is displayed.
