## Introduction & Overview

The objective of this mock trading session is to ensure customers can receive and process MBO market data in MDP 3.0 format in the CME Globex production environment prior to the launch scheduled for **Sunday, March 11, 2017**.

For this mock trading session, Simple Binary Encoding (SBE) MDP 3.0 market data messages will be broadcast on the following channels:

This mock trading session only supports front-end testing. End-to-end testing through Clearing will not be available.
