Earlier today, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") delisted sixteen (16) US & European Monthly and Seasonal HDD futures contracts as set forth in Tables 1. and 2.

The delisting of the contracts in Table 1. is a result of the Exchange's prior announcement that the last listed contract month for these contracts shall be April 2016 (see SER [7404](#) dated July 6, 2015). The Exchange previously notified the Commodity Futures Trading Commission ("CFTC") of the delisting of previously listed contracts months of the Contracts in Table 1. (CME Submission No. 15-202 dated July 6, 2015). The CFTC will be notified of the delisting of the Contracts in Table 1. during the week of May 16, 2016, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.

As a result of the delisting, information regarding these sixteen (16) contracts have been deleted from the respective product rule chapters, related position limits in the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 (Trading Qualifications and Practices) of the CME Rulebook, the CME Globex non-reviewable ranges located in Rule 588.H. of the CME Rulebook, and the list of block-eligible products located on the CME Group website.
