E-mini Nifty 50 Index Futures Price Limits Effective for February 2018

Effective Wednesday, January 31, 2018, for trade date Thursday, February 1, 2018, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will amend price limits for E-mini Nifty 50 Index Futures (CME Rulebook Chapter 382; CME Globex code: MNF; Clearing code: II) as described below. The contract is listed for trading on the CME Globex electronic trading platform and for submission for clearing through CME ClearPort.

Contract	10% up and down	15% up and down	20% up and down
E-mini Nifty 50 Index Futures	1,100.00	1,650.00	2,200.00

Exchange Rules call for the limits to be re-calculated monthly at the close of business on the day preceding the commencement of a new calendar month.
