Processing of Performance Bond Collateral

There will be no collateral processing for Monday, October 8, 2018, due to the Columbus Day holiday.

The "Interest-Earning Facility" (IEF) will be closed for all transactions on **Monday**, **October 8**th. No purchases or redemptions will be allowed for the IEF-2 or IEF-4 programs on Monday, October 8th. **Please refer to IEF2 processing deadline schedules for Friday**, **October 5**th, **on the last page of this advisory**.

A.M. Settlement Confirmations

Settlement variation and performance bond cash call/release amounts resulting from Friday, October 5th and Monday, October 8th RTH settlement cycles will be confirmed by the settlement banks by 7:30 a.m. on Tuesday, October 9th.

Settlement banks will process cash flows resulting from Thursday and Friday's RTH settlement cycle on Tuesday, October 9th.

As securities near their maturity date, the values of these assets change, this can result in a change to their Performance Bond values at CME. With this, you may see changes in the asset values on deposit with CME on Tuesday, morning after the holiday. Increase/decrease in the values of these collateral assets from Thursday and Friday may result in PB call/release, which would be banked on Tuesday, morning. These PB calls/releases would be banked in addition to the regular RTH settlements for Thursday and Friday

Futures Foreign Currency Performance Bond Cash Withdrawals

Due to the holiday's effects on transaction processing, please note the following value dates on foreign currency performance bond cash withdrawals placed before 9am CST. Transactions placed after 9am CST will have one additional business day added to the value date.
