Effective Sunday, February 21, (trade date Monday, February 22) Chicago Mercantile Exchange, Inc. (CME or EXCHANGE) will list

- Week 3 European Style Options (EV3) on Standard and Poor's 500 Stock Price IndexTM
 Futures replacing American Style Serial Options on Standard and Poor's 500 Stock
 Price IndexTM Futures, and
- 2) Week 3 European Style Options (EW3) on E-mini[®] Standard and Poor's 500 Stock Price Index Futures **replacing** American Style Serial Options on E-mini[®] Standard and Poor's 500 Stock Price Index Futures.

April 2016 and May 2016 American Style Serial Options currently listed for trading will not be affected and will expire as regularly scheduled. **No new American Style Serial option months will be listed upon expiration of these option contracts**.
