This program requires facilities that emit over 25,000 tons of carbon dioxide equivalents per year to surrender allowances - one per ton emitted. GreenX will launch California Carbon Allowance (CCA) Futures contracts in response to this new compliance market. These contracts will be available for trading on Globex and clearing through ClearPort.
