

1. Overview

CME Clearing produces 2 daily reports for Clearing Members to monitor US dollar cash collateral in relation to US dollar initial margin requirements to identify, for each settlement account, if the required cash minimum is met for that day. If the cash minimum is not met for a given settlement account, the Clearing Member is charged a higher rate on custody fees for that day.

The first report (CAl800C) is generated at the completion of each end-of-day ("EOD") clearing cycle as a preliminary indication of USD cash as a % of requirements from that night. The US dollar cash collateral amount is inclusive of CCF adjustments and PB calls from that cycle which are banked the following business day morning. This report can be used at start-of-day ("SOD") that following morning by Clearing Members to see how much US dollar cash is needed to meet the cash minimum for the calculation that will occur later in the evening.

The second report (CAI801C) is produced when the calculation runs in the evening (approx. 5pm CT) using current US dollar cash compared against the prior night's EOD total US dollar requirement. This report should be considered the actual determination of whether a Clearing Member is meeting the cash minimum.

2.1. File Naming Conventions

Reports are available through EREP and also pushed to Clearing Member's Outgoing folders on SFTP

EREP

- CAI800C preliminary report showing cash levels after EOD settlement cycle
- CAI801C final report showing results of the calculation and indication of any additional custody fee

SFTP ("nnn" corresponds to CMF number)

- CAI800C.CME.yyyymmdd.nnn.csv preliminary report showing cash levels after EOD settlement cycle
- CAI801C.CME.yyyymmdd.nnn.csv- final report showing results of the calculation and indication of any additional custody fee
