SUBJECT: Monday, September 19, 2022 – State Funeral of Her Majesty, Queen

Elizabeth II - UK Bank Holiday

The UK Government has announced that the day of the State Funeral of Her Majesty, Queen Elizabeth II on Monday, September 19, 2022, will be a UK bank holiday.

## IMPACT ON PRODUCTS

**INTEREST RATES:** As a result of the <u>ICE Benchmark Administration (IBA)</u> announcement, the last trading day for the expiring September 2022 One-Month Eurodollar Futures (CME Chapter 453) and the expiring September 2022 Three-Month Eurodollar Futures (CME Chapter 452) and Options (CME Chapter 452A) will be Friday, September 16, 2022. Please refer to the Final Settlement rules (45303.A.) and (45203.A.) for additional details.

Additionally, due to the UK bank holiday, the last trading day for expiring September 2022 MAC USD and SOFR Swap Futures will be Friday, September 16, 2022. Quarterly IMM SONIA Futures and MPC SONIA Futures will not be available for trading and clearing.

**EQUITY INDEX:** Basis Trade on Index Close ("BTIC") transactions only are impacted. All London-based Equity Index products, including BTIC block trades, will not be available on Sunday, September 18, 2022 for trade date Monday, September 19, 2022. BTIC transactions will not be permitted on the Adjusted Interest Rate FTSE 100® Total Return Declared Dividend Index Futures (BTIC code: AFT), including combination transactions, E-mini FTSE® 100 Index Futures (BTIC code: FTT), and E-Mini USD Denominated FTSE® 100 Index Futures (BTIC code: FTB) on Monday, September 19, 2022. All outright and calendar spread trading on all London-based Equity Index products will remain available for trading and clearing.

**ENERGY:** As a result of <u>The Baltic Exchange</u>, <u>S&P Global Platts</u>, and <u>Argus Media</u><sup>1</sup> announcements, the energy futures contracts listed below will not be available for trading and clearing on September 19, 2022.
