SUBJECT: Position Limits, Accountability Levels and Large Trader Reporting Requirements in Connection with the Initial Listing of Two (2) Dutch TTF and Two (2) UK NBP Natural Gas Option Contracts

In connection with the listing of New York Mercantile Exchange, Inc.'s ("NYMEX" or "Exchange") two (2) Dutch TTF and two (2) UK NBP Natural Gas Option Contracts on trade date Monday, September 9, 2019 (see [SER-8429](#) published August 13, 2019), please note below and in [Exhibit B](#) of NYMEX Submission No. [19-263](#), the corresponding spot-month position limits (Rule 559), aggregation allocations (Rule 559.D.), single month and all month accountability levels (Rule 560) and reportable levels (Rule 561) for the new contracts.
