SUBJECT: Initial Listing of Singapore Fuel Oil Bunker 380 cst (Argus) Futures Contract

(This SER supersedes SER 8413 dated July 30, 2019 to amend the effective date from trade date Monday, April 26, 2019 to trade date Monday, August 26, 2019. In addition, the block trade minimum threshold is amended from 2 contracts to 5 contracts. No other changes have been made to the original SER.)

Effective Sunday, August 25, 2019, for trade date Monday, August 26, 2019, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list the Singapore Fuel Oil Bunker 380 cst (Argus) Futures contract (the "Contract") for trading on the CME Globex electronic platform and for submission for clearing via CME ClearPort as noted in the table below.
