SUBJECT: Preliminary Information Regarding the Upcoming Listing of Event Contract

Options on Certain CME Group Futures Contracts

Further to the <u>Press Release</u>, dated March 14, 2022 (and pending all relevant CFTC regulatory review periods), Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT"), New York Mercantile Exchange, Inc. ("NYMEX") and Commodity Exchange, Inc. ("COMEX") (collectively the "Exchanges") are providing <u>preliminary</u> information on the upcoming listing of Event Contract Options on certain CME Group futures on equity, foreign exchange (FX), energy and metals contracts as noted in Table 1. below (the "Event Contracts") for trading on the CME Globex electronic trading platform ("CME Globex").

Event Contracts are daily-expiring, cash settled, European Style, binary-options on futures contracts, offering short-term trading opportunities for individuals seeking to take a position on daily price moves on futures using smaller-value trades of up to \$20 per contract.

The Event Contracts allow market participants to trade their view on the price direction of key futures markets at the end of each day's trading session.

4 strikes at \$1.00 per barrel strike increment above and below the at-the-money strike then 4 strikes in \$2.50 per barrel increment on the nearest \$2.50 per barrel interval above and below the highest and lowest \$1.00 per barrel increment strikes.
