SUBJECT: Amendments to the CME Globex Trading Hours of the Four (4) Mini-Sized Agricultural Futures Contracts

Effective Sunday, October 2, 2022, for trade date Monday, October 3, 2022, and pending all relevant CFTC regulatory review periods, The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") will amend the CME Globex electronic trading ("CME Globex") hours of the four (4) agricultural mini-sized futures contracts, as detailed in the table below.
