Aluminum MW U.S. Transaction Premium Platts (25MT) Average Option

1144100. SCOPE OF CHAPTER

This chapter is limited in application to put and call options on Aluminum MW U.S. Transaction Premium Platts (25MT) Futures. In addition to the rules of this chapter, transactions in options on Aluminum MW U.S. Transaction Premium Platts (25MT) Futures shall be subject to the general rules of the Exchange insofar as applicable.

1144101. OPTION CHARACTERISTICS

The number of months open for trading at a given time shall be determined by the Exchange.

1144101.A. Trading Schedule

The hours of trading for this contract shall be determined by the Exchange.

1144101.B. Trading Unit

An Aluminum MW U.S. Transaction Premium Platts (25MT) Average Price put option traded on the Exchange represents the cash difference between the exercise price and the settlement price of the Aluminum MW U.S. Transaction Premium Platts (25MT) Futures multiplied by 55,116, or zero, whichever is greater. An Aluminum MW U.S. Transaction Premium Platts (25MT) Average Price call option traded on the Exchange represents the cash difference between the settlement price of the Aluminum MW U.S. Transaction Premium (Platts (25MT) Futures and the exercise price multiplied by 55,116, or zero, whichever is greater.

1144101.C. Price Increments

Prices shall be quoted in dollars and cents per pound and shall be in multiples of \$0.00001 per pound.

1144101.D. Position Limits and Position Accountability

The applicable position limits and/or accountability levels, in addition to the reportable levels, are set forth in the Position Limit, Position Accountability and Reportable Level Table in the Interpretations & Special Notices Section of Chapter 5.

A Person seeking an exemption from position limits for bona fide commercial purposes shall apply to the Market Regulation Department on forms provided by the Exchange, and the Market Regulation Department may grant qualified exemptions in its sole discretion.

Refer to Rule 559 for requirements concerning the aggregation of positions and allowable exemptions from the specified position limits.

1144101.E. Termination of Trading

The option shall expire at the close of trading on the last day of trading of the underlying Aluminum MW U.S. Transaction Premium (Platts) Futures contract.

1144101.F. Type Option

The option is a European-style option which can be exercised only on the expiration day.

1144102. EXERCISE PRICES AND CHARACTERISTICS

Transactions shall be conducted for option contracts as set forth in Rule 300.20.
