

Changes to observation windows for the calculation of Term SOFR on January 9th 2025

03 January 2025

Following the announcement of a National Day of Mourning in the U.S. in observance of the passing of Former President Jimmy Carter, to be held on January 9,2025, changes to CME Globex trading schedules on January 9, 2025 will result in the following adjustments to the calculation of the CME Term SOFR Benchmarks on January 9, 2025:

- The Benchmarks will be published as normal on January 9, and 10 2025 at 5am CT
- For the CME Term SOFR publication on January 10, 2025 the calculation will use fewer observation windows with intervals running from 7am CT to 11am CT due the early close of CME Globex trading session for interest rate products on January 9, 2025
