

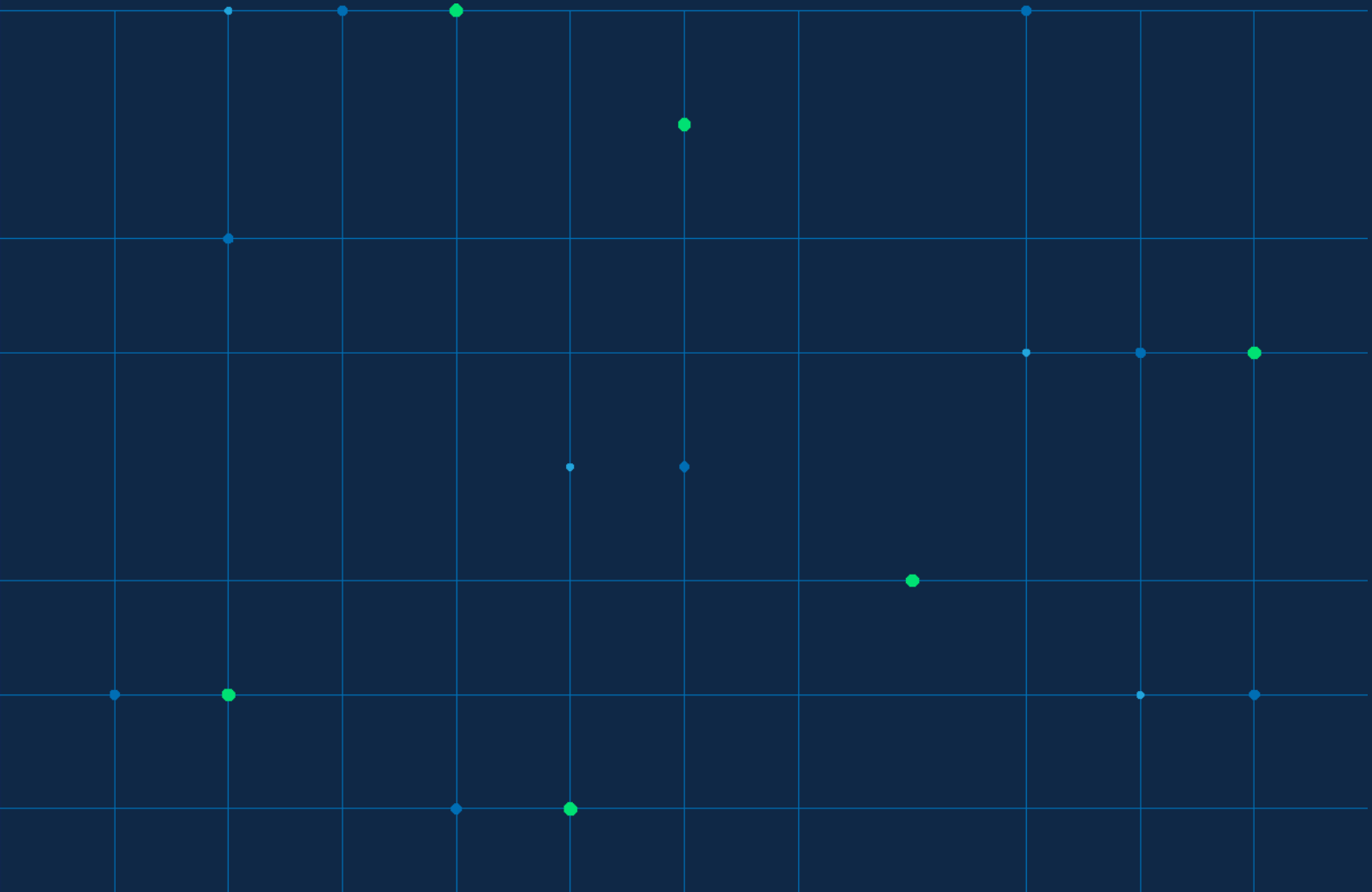

Introduction

CME Group Benchmark Administration Limited (CBA or the Administrator) has created the CME Group Rolling Futures Index family to provide clients with a set of end-of-day indices that individually represent the performance of a continuous rolling investment in an underlying futures contract. The CME Group Rolling Futures Index family consists of indices referencing CME Group's leading futures markets across the Agriculture, Metal, Energy, FX, Cryptocurrency, Treasury and Credit markets.

CBA is authorised and supervised by the UK Financial Conduct Authority (FCA). CBA is the Benchmark Administrator of the CME Group Rolling Futures Indices, with Chicago Mercantile Exchange Inc. (CME Inc.) providing calculation agent and distribution services.

The CME Group Rolling Futures Index Methodology uses the settlement prices of futures contracts calculated and published by CME Group. These futures contracts are traded on CME Group's Designated Contract Markets (DCM's): Chicago Board of Trade (CBOT), Commodity Exchange (COMEX), New York Mercantile Exchange (NYMEX) and Chicago Mercantile Exchange (CME).

Index values will be published after the settlement prices are released and made public for each futures contract.

The overarching calculation methodology is identical for all the indices, however the contracts used as well as the timing and duration of the underlying contract roll have been chosen to follow the liquidity profile of each asset.

The CME Group Rolling Futures Indices is a family of benchmarks based on industry best practices and the IOSCO Principles for Financial Benchmarks.
