

IOSCO Compliance Statement

CME Group Benchmark Administration Limited Publication Date: November 3rd, 2022





Introduction

CME Term SOFR Reference Rates are a daily set of forward-looking interest rate estimates, calculated and published for 1-month, 3-month, 6-month and 12-month tenors. Each CME Term SOFR Reference Rates tenor will start on (and include) the second US Government Securities Business Day following the publication day and span the corresponding tenor in accordance with Modified Following day-count conventions.

The CME Term SOFR Reference Rates will be published on the next Business Day following the Business Day during which futures data sampling takes place and are computed based on a Reference Period that begins two business days (T+2) after the Publication Date.

CME Term SOFR Reference Rates will be calculated in accordance with the recommended SIFMA US Holiday Schedule¹. Publication will occur at 5.00am CT (6.00am ET, typically 11.00am GMT).

CME Group Benchmark Administration Ltd (CBA) is the benchmark administrator with CME Group Inc. providing Calculation Agent and distribution services.

Regulatory and IOSCO Compliance

The CME Term SOFR Reference Rates are a family of benchmarks based on industry best practices and the IOSCO Principles for Financial Benchmarks. This will include but not be limited to the creation of an Oversight Committee and a published Methodology. The Index will also be subject to an Audit process. Material changes to the Methodology will be announced via public consultation and any changes would be announced with a notice period of at least one (1) month.

Capitalised terms not otherwise defined in this document have the meaning given to them in the IOSCO Principles for Financial Benchmarks Final Report of July 2013.

SOFR means Secured Overnight Financing Rate.

During each window, a VWAP of executed transactions in SOFR Future contracts and snapshots of their executable bid-ask are taken to determine a Settlement Price for each observation window. Those are then weighted in the final benchmarks' calculation. Once the Overnight Index Swaps (OIS)
		market meets a relative volume threshold with the SOFR Futures market, OIS will also be included in the calculation of the benchmarks.
	b) Size and liquidity of the relevant market (for example whether there is sufficient trading to provide observable, transparent pricing);	Trading in CME SOFR futures, which underpin the CME Term SOFR Reference Rates, has grown to above 1,000,000 contracts (over \$1.6 trillion in notional equivalent principal value) and is expected to grow further. In addition to the actual volume of transactions, CME SOFR futures markets show consistently actionable quotes in a regulated central limit order book for significant proportions of the trading day, supported by market makers that have committed to streaming quotes for the majority of the relevant trading hours.
