SUBJECT: Addition of AvgPx (True Average Price) Tag to all Average Price Records on FIXML Trade Register

At the request of Clearing Member Firms, beginning on Monday, November 20, 2017, CME Clearing will include the True Average Price for all allocations and offsets that have an Average Price on the EOD FIXML trade register. Currently, re-allocations of claimed average price allocations do not include this tag, but will after this change.

In real-time messaging, True Average Price is represented with the **AvgPx** tag for regular Average Price allocations and with the **TrueAvgPx** tag on Average Price Re-allocation messages. However, for both of these scenarios, the **AvgPx** tag will be used on the FIXML Trade Register. This change should not require any modification to firms' current FIXML trade register processing, as the tag is currently used for regular Average Priced Allocations and Offsets.
