SUBJECT: Product Modification Summary for Clearing Firms, Bookkeeping Software Providers, ISVs

Effective Sunday, March 3, for trade date Monday, March 4, the New York Mercantile Exchange, Inc. (NYMEX or EXCHANGE) will amend the strike listing rule for Platinum and Palladium Options on CME Globex and for submission for clearing on CME ClearPort. Additionally, the strike increment for Platinum Option is reduced from \$10.00 per troy ounce to \$5.00 per troy ounce.

PO/PO	Platinum Option	Minimum 6 strikes at \$10.00 per troy ounce strike increment above and below the at- the-money strike. Dynamic strikes at \$10.00 per troy ounce strike increment above and below the highest and lowest pre-listed strikes.	Minimum 30 strikes at \$5.00 per troy ounce strike increment above and below the at-the- money strike then 4 strikes at \$25.00 per troy ounce strike increment above and below the highest and lowest \$5.00 increment strike for the nearest 3 months. Minimum 5 strikes at \$5.00 per troy ounce strike increment above and below the at-the- money strike for months 4+.
