SUBJECT: Product Modification Summary for Clearing Firms, Bookkeeping Software Providers, ISVs

Effective Sunday, March 27, 2022, for trade date Monday, March 28, 2022, and pending all relevant CFTC regulatory review periods, The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") will increase the September 2022 coupon rates for all of the Eris US Dollar Swap Futures, Eris SOFR Swap Futures, and MAC SOFR Swap Futures contracts (the "Contracts") as noted in the table below. There is no open interest in the September 2022 contract month of the Contracts.

Effective immediately, the Exchange will suspend trading and clearing of the September 2022 contract month of the Contracts and related calendar spreads until Monday, March 28, 2022.
