SUBJECT: Product Modification Summary for Clearing Firms, Bookkeeping Software Providers, ISVs

Effective November 17, 2022, The New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") shall cease listing additional contract months for the below products for trading on CME Globex and for submission for clearing on CME ClearPort.

Effective immediately, the Exchange will temporarily suspend trading and clearing of certain previously listed contract months indicated below until further notice. There is no open interest in the Impacted Contract Months.

Further, the Exchange intends to subsequently suspend trading and clearing of additional previously listed contract months in the event there is no open interest in those contract months.
