SUBJECT: SPAN 2 Indicative Margins on CME Website

Beginning July 21st, the CME Group website will be enhanced to display margin requirements for the SPAN 2 framework. This feature is expected to be available at approximately 1 PM CT. Website users will navigate to the same location they do today to view margin requirements. Users will be able to see outright and spread margin requirements for the contracts specified on the webpage.

Margins, also known as Performance Bonds are deposits required to ensure that a clearing member can cover potential losses with his or her trading positions. Margins / Performance bonds help to ensure that clearing members can meet their obligations to their customers and to CME Clearing. Performance bonds/margins vary according to product and market volatility.
