SUBJECT: SPAN 2 Framework Energy Product Addition to Cross Model Offset ("CMO")

As per normal review, CME Clearing's Risk Management staff approved the addition of the following products to the SPAN 2 framework's cross model offset ("CMO") against products that are margined in the SPAN 2 framework's crude pod. For avoidance of doubt, products that are added to CMO continue to be margined under the SPAN methodology, however they may receive margin offsets against products that are margined under the SPAN 2 methodology.
