SUBJECT: Position Limits, Accountability Levels and Large Trader Reporting Requirements in Connection with the Initial Listing of the Ethanol T2 FOB Rdam Including Duty (Platts) BALMO Futures Contract

In connection with the listing of New York Mercantile Exchange, Inc.'s ("NYMEX" or "Exchange") Ethanol T2 FOB Rdam Including Duty (Platts) BALMO Futures contract on trade date Monday, April 24, 2017 (see [SER-7874](#) published March 28, 2017), please note below and in [Appendix B](#) of NYMEX Submission No. [17-107](#), the corresponding spot month position limits (Rule 559), aggregation allocations (Rule 559.D.), single month and all month accountability levels (Rule 560) and reportable levels (Rule 561) for the new contract. The new, financially settled, contract shall have diminishing balances.
