SUBJECT: Position Limits, Accountability Levels and Large Trader Reporting

Requirements in Connection with the Initial Listing of Two (2) Crude

Oil Spread Futures Contracts

In connection with the listing of New York Mercantile Exchange, Inc.'s ("NYMEX" or "Exchange") two (2) crude oil spread futures contracts on trade date Monday, August 5, 2019 (see <u>SER-8411R</u> published July 18, 2019), please note below and in <u>Exhibit B</u> of NYMEX Submission No. <u>19-247</u>, the corresponding spotmonth position limits (Rule 559), aggregation allocations (Rule 559.D.), single month and all month accountability levels (Rule 560) and reportable levels (Rule 561) for the new contracts. The new, financially settled, contracts shall have diminishing balances.
