## Listing of S&P GSCI Commodity Index Futures Contract for Clearing via CME ClearPort

Effective Sunday, 22 May 2016, for trade date Monday, 23 May 2016, and pending all relevant CFTC regulatory review periods, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") shall make S&P GSCI™ Commodity Index Futures contract (CME Rulebook Chapter: 401; Clearing Code: GI; CME Globex Code: GI) (the "Contract") available for submission for clearing through CME ClearPort. The Contract is currently listed for trading on the CME Globex electronic trading platform.

The Exchange is adding the CME ClearPort venue to the Contract to support the submission of trades for clearing to the Exchange. Please note that this action does not change any previously approved trade types of strategies, nor does it change any products listed for trading on CME.

CME ClearPort hours are Sunday through Friday, 5:00 p.m. to 4:00 p.m. Chicago time (CT), with a one-hour break Monday through Thursday, beginning at 4:00 p.m. CT.
