("COMEX" or "Exchange") will expand the listing schedules of the following contracts as noted in the table below: Aluminum MW U.S. Transaction Premium Platts (25MT) Futures (Rulebook Chapter: 1189; Commodity Code: AUP), Aluminium European Premium Duty-Unpaid (Metal Bulletin) Futures (Rulebook Chapter: 108; Commodity Code: AEP), Aluminium European Premium Duty-Paid (Metal Bulletin) Futures (Rulebook Chapter: 1109; Commodity Code: EDP), Aluminum Japan Premium (Platts) Futures (Rulebook Chapter: 109; Commodity Code: MJP). These contracts are available for trading via CME Globex and for submission into clearing via CME ClearPort.
