SUBJECT: Expansion of Listing Schedule for the Existing Henry Hub Natural Gas Financial

Calendar Spread Option Contracts

Effective Sunday, April 23, 2017 for trade date Monday, April 24, 2017, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will expand the listing schedule for the Henry Hub Natural Gas Financial Calendar Spread Option contracts (Rulebook Chapter 399) which are available for trading on CME Globex and for submission for clearing through CME ClearPort, as noted in the table below.
