SUBJECT: Initial Listing of the Urea (Granular) FOB Middle East Futures Contract

As previously announced on May 19, 2017 (see <u>SER-7920</u>), effective Sunday, June 25, 2017, for trade date Monday, June 26, 2017, and pending all relevant CFTC regulatory review periods, The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") intends to list the Urea (Granular) FOB Middle East Futures contract (commodity code: UME; rulebook chapter: 44) for trading on the CME Globex electronic trading platform, and for submission for clearing via CME ClearPort as noted in the table below.
