**SUBJECT:** Initial Listing of the Micro Coal (API 5) fob Newcastle (Argus/McCloskey) Futures Contract

Effective Sunday, July 9, 2017, for trade date Monday, July 10, 2017, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list the Micro Coal (API 5) fob Newcastle (Argus/McCloskey) Futures contract (the "Contract") for trading on the CME Globex electronic platform and for submission for clearing via CME ClearPort as more specifically described below.

<b>Contract Size</b>	10 MT (metric tons)
<b>Listing Schedule</b>	Monthly contracts listed for the current year and the next calendar year. Monthly contracts for a new calendar year will be added following the termination of trading in the December contract of the current year.
<b>Minimum Price Fluctuation</b>	\$0.05 per metric ton
<b>Value per Tick</b>	\$0.50
<b>First Listed Month</b>	July 2017
<b>Block Trade Minimum Threshold</b>	100 contracts
<b>Termination of Trading</b>	Trading terminates on the last Friday of the contract month. If such Friday is a UK holiday, trading terminates on the UK business day immediately prior to the last Friday of the contract month unless such day is not an Exchange business day, in which case trading terminates on the Exchange business day immediately prior. Notwithstanding the above, if New Year's Day is a Friday, the immediately preceding December contract month terminates on the last business day of the contract month.
