SUBJECT: Initial Listing of the WTI vs. Dubai Crude Oil (Platts) Futures Contract

Effective Sunday, December 17, 2017, for trade date Monday, December 18, 2017, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list the WTI vs. Dubai Crude Oil (Platts) Futures contract (the "Contract") for trading on the CME Globex electronic platform and for submission for clearing via CME ClearPort as noted in the table below.

Floating Price	The Floating Price for each contract month is the arithmetic average of the Light Sweet Crude Oil Futures first nearby contract settlement price minus the arithmetic average of the mid-point between the high and low quotations from Platts Crude Oil Marketwire for the Dubai front month price for each business day during the contract month (using Non-common pricing).

Termination of Trading	Trading shall cease on the last business day of the contract month
Block Trade Minimum Threshold	10 contracts
