SUBJECT: Basis Trade at Index Close (“BTIC”) Eligibility on CME Globex and Expansion of Listing Schedule for Certain CME and CBOT Equity Index Futures Contracts

Effective Sunday, March 25, 2018 for traded date Monday, March 26, 2018, Chicago Mercantile Exchange, Inc. (“CME”) and The Board of Trade of the City of Chicago, Inc. (“CBOT”) (collective, the “Exchanges”) will permit Basis Trade at Index Close (“BTIC”) trading on CME Globex and expand the listing schedule of certain CME and CBOT equity index futures contracts as more specifically described below:

- (1) The Exchange shall permit the following products to be eligible for Basis Trade at Index Close (“BTIC”) trading on the CME Globex electronic trading platform (“CME Globex”):

- (2) The Exchange shall expand the listings schedule of the E-mini S&P Select Sector Index Futures and the E-mini NASDAQ Biotechnology Index Futures contracts for trading on CME Globex and for submission for clearing on CME ClearPort. Currently, at any given time the two (2) nearest delivery months in the March Quarterly cycle (March, June, September, or December) are listed for trading in each of the Contracts. Effective on trade date March 26, 2018, at any given time the five (5) nearest delivery months in the March Quarterly will be listed for trading and clearing in each of these contracts.
