Adoption of Disclaimer Rules for the U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures and E-Micro U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures Contracts

Effective Tuesday, July 17, 2018, and pending all relevant CFTC regulatory review periods, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") shall adopt disclaimer rules for U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures and E-Micro U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures contracts noted in the table below (the "Contracts"). The Contracts are available for trading on CME Globex and for submission for clearing via CME ClearPort.

Contract Title	CME Rulebook Chapter	Commodity Code
U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures	284L	CNH
E-Micro U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures	344L	MNH

Specifically, CME is adopting Rules 284L03. ("Disclaimer") and 344L03. ("Disclaimer") in CME Rulebook Chapter 284.L U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures and CME Rulebook Chapter 344.L E-Micro U.S. Dollar/Offshore Chinese Renminbi (USD/RMB) Futures contracts, respectively (collectively the "Rule Amendments"). The Rule Amendments provide the appropriate disclaimer regarding the use of the TMA HKG USD/CNY(HK) Rate for the final settlement price of the Contracts which is published by the Treasury Markets Association of Hong.
