### Price Limit Offset Levels Revised for CME Nikkei Stock Average Futures and CME TOPIX Index Futures

**Effective for Trade Date Tuesday, September 4, 2018**

The Offset Levels for the determination of CME Nikkei Stock Average futures and CME TOPIX Index futures price limits are revised to the following levels, effective as of the commencement of Electronic Trading Hours (ETH) on Sunday, September 2, 2018, at 5:00 p.m. Chicago time.\* These offset levels shall be in force until the close of trading on Friday, November 30, 2018. The Price Limit Offset Levels are as follows:

Exchange Rules call for the Offset Levels to be re-calculated every three months at the end of February, May, August, and November preceding the commencement of the next three-month period. Such three-month periods include: March through May; June through August; September through November; and December through February.
