**SUBJECT:** Addition of CME ClearPort Clearing Venue to Certain Existing Agricultural Calendar Spread Options Contracts

Effective Sunday, December 2, 2018 for trade date Monday, December 3, 2018, and pending all relevant CFTC regulatory review periods, The Board of Trade of the City of Chicago, Inc. ("CBOT" or "Exchange") shall permit submission for clearing via CME ClearPort six (6) existing agricultural calendar spread options contracts (the "Contracts") as described below.

The block trade minimum level for the Contracts will be 100 contracts during regular trading hours and 50 contracts during all other trading hours. Additional information regarding block trades may be found [HERE](#).

The Contracts are currently listed for trading on the CME Globex electronic trading platform and the CBOT trading floor.
