SUBJECT: Initial Listing of the Japan Crude Cocktail (Detailed) Futures Contract

Effective Sunday, March 31, 2019, for trade date Monday, April 1, 2019, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list the Japan Crude Cocktail (Detailed) Futures contract (the "Contract") for trading on the CME Globex electronic platform and for submission for clearing via CME ClearPort as noted in the table below.
