SUBJECT: Initial Listing of Two (2) Crude Oil Spread Futures Contracts

(This SER supersedes SER 8411 dated July 9, 2019 to amend the effective date from trade date Monday, July 29, 2019 to trade date Monday, August 5, 2019. No other changes have been made to the original SER.)

Effective Sunday, August 4, 2019, for trade date Monday, August 5, 2019, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list two (2) crude oil spread futures contracts provided in the table below (the "Contracts") for trading on CME Globex electronic trading platform and for submission for clearing via CME ClearPort.
