SUBJECT: Initial Listing of the Cobalt Metal (Fastmarkets) Futures Contract

Effective Sunday, December 13, 2020, for trade date Monday, December 14, 2020, and pending all relevant CFTC regulatory review periods, Commodity Exchange, Inc. ("COMEX" or "Exchange") will list the Cobalt Metal (Fastmarkets) Futures contract (the "Contract") for trading on the CME Globex electronic platform ("CME Globex") and for submission for clearing via CME ClearPort as noted in the table below.
