SUBJECT: Delisting of Twenty-Five (25) Petroleum Futures and Option Contracts

Effective today, Monday, July 26, 2021, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") delisted twenty-five (25) petroleum futures and option (the "Contracts") as set forth in the table below. There is no open interest in the Contracts.
