SUBJECT: Amendments to Align CME Globex and CME ClearPort Listing Schedules of Nine (9) FX Options Contracts

Effective Sunday, November 7, 2021 for trade date Monday, November 8, 2021, and pending all relevant Commodity Futures Trading Commission ("CFTC") regulatory review periods, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will align the listing schedules of nine (9) foreign exchange ("FX") options contracts listed below ("the Contracts") for trading on the CME Globex electronic trading platform ("CME Globex") and for submission for clearing via CME ClearPort as also noted in the table below.
