SUBJECT: CME Group Holiday Calendar – Juneteenth Holiday

Chicago Mercantile Exchange Inc. ("CME"), The Board of Trade of the City of Chicago, Inc. ("CBOT"), New York Mercantile Exchange, Inc. ("NYMEX"), and Commodity Exchange, Inc. ("COMEX") (collectively, the "Exchanges") recently published the 2022 holiday calendar. Commencing in 2022, the Exchanges will observe the Juneteenth holiday each year.

As a result, the last trading date for the following contract months of certain CME, CBOT and NYMEX futures and options contracts will be impacted as noted in the tables below.

SIFMA has recognized Juneteenth and recommends full market close in observance of the Juneteenth National Independence Day. As a result, on Wednesday, June 19, 2024, the market will be closed during a prior scheduled final settlement day for CME Three-Month SOFR Futures contract (the "Contract"). Pursuant to CME Chapter 460 the Contract allow for the Final Settlement Price to be published on a day other than the third Wednesday of the contract delivery month. The Settlement Procedures require the Final Settlement Price to be calculated and published on the first day that the FRBNY publishes the value for the last day of the expiring contracts Reference Quarter.

As such, the **March 2024 contract month** of the Contract will expire on Tuesday, June 18, 2024 with Final Settlement Price to be published on Thursday, June 20, 2024. The last term in the calculation of the Final Settlement will be the SOFR value published by the FRBNY on Thursday, June 20, 2024 which will apply for one day, Tuesday, June 18, 2024.

Similarly, the reference period for the **June 2024 contract month** of the Contract will begin on Wednesday, June 19, 2024. Whereby the first term in the Final Settlement calculation will also be the SOFR value published by the FRBNY on Thursday, June 20, 2024 which will apply for one day, Wednesday, June 19, 2024.
