SUBJECT: Initial Listing of the Micro NY Harbor ULSD Futures and Micro RBOB Gasoline Futures Contracts

Effective Sunday, June 26, 2022, for trade date Monday, June 27, 2022, and pending all relevant CFTC regulatory review periods, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") will list the Micro NY Harbor ULSD Futures and Micro RBOB Gasoline Futures contracts (the "Contracts") for trading on the CME Globex electronic trading platform ("CME Globex") and for submission for clearing via CME ClearPort as noted in the table below.
