



## Special Executive Report

**SER#:** 9069R

**SUBJECT:** Enabling Dynamic Strike Creation for Select FX Options Contracts

(SER 9069R supersedes SER 9069 dated November 8, 2022 to amend the new Rule 2XXXA01.4. ("Dynamically-Listed Exercise Prices") of the Contracts such that dynamic strikes shall only be added at regularly-defined intervals. No other changes have been made to the original SER.)

Effective Sunday, December 4, 2022 for trade date Monday, December 5, 2022, Chicago Mercantile Exchange Inc. ("CME" or "Exchange") will enable dynamic strike creation for select foreign exchange ("FX") options contracts (the "Contracts") on the CME Globex electronic trading platform ("CME Globex") and for submission of clearing via CME ClearPort as more specifically described in the table below.

Specifically, the Exchange is implementing amendments to CME Rule 25XA01.K.4 Dynamically-Listed Exercise Prices of CME Chapter 251A (“Options on British Pound Sterling/U.S. Dollar (GBP/USD) Futures”), CME Chapter 252A (“Options on Canadian Dollar/U.S. Dollar (CAD/USD) Futures”), CME Chapter 253A (“Options on Japanese Yen/U.S. Dollar (JPY/USD) Futures”), CME Chapter 254A (“Options on Swiss Franc/U.S. Dollar (CHF/USD) Futures”), CME Chapter 255A (“Options on Australian Dollar/U.S. Dollar (AUD/USD) Futures”), and CME Chapter 261A (“Options on Euro/U.S. Dollar (EUR/USD) Futures”) to enable dynamic strike creation for the Contracts (the “Rule Amendments”).

Market participants may request additional strike prices for trading on CME Globex or for submission of clearing via CME ClearPort. These additional strikes are added on an "as soon as possible" basis.

The CFTC will be notified of the Rule Amendments during the week of December 12, 2022, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.
