**SUBJECT: Delisting of Thirteen (13) Canadian Crude Oil Futures and Options Contracts**

Effective today, Monday, February 27, 2023, New York Mercantile Exchange, Inc. ("NYMEX" or "Exchange") delisted the thirteen (13) Canadian crude oil futures and options contracts set forth in the table below (the "Contracts"). There is no open interest in the Contracts.

The Contracts were previously listed for trading on CME Globex electronic trading platform ("CME Globex") as well as for submission for clearing via CME ClearPort.

The Exchange previously amended the listing schedule for the NE2 futures and options contracts (the "NE2 Contracts") and suspended trading and clearing of certain previously listed contract months of the NE2 Contracts. See NYMEX Notice [SER-9080](#) dated November 1, 2022.

As a result of the delisting, information regarding the Contracts has been deleted from the respective product rulebook chapters, related position limits in the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 ("Trading Qualifications and Practices") of the NYMEX Rulebook, the CME Globex non-reviewable trading ranges located in Rule 588.H. of the NYMEX Rulebook, and the list of block-eligible products located on the CME Group website.
