**SUBJECT:** Administrative Amendments to the Contract Title of all Micro Yield Futures Contracts

Effective Monday, February 5, 2024, The Board of Trade of the City of Chicago, Inc. (“CBOT” or “Exchange”) will implement administrative amendments to the contract title of all Micro Yield futures contracts (the “Contracts”) as more specifically noted in Table 1. below (collectively, the “Amendments”).
