### **S&P CNX Nifty Price Limits Effective for November 2010**

Price limits for S&P CNX Nifty index futures are revised to the following levels, effective as of commencement of Electronic Trading Hours (ETH) on Sunday, October 31, 2010, at 5:00 p.m. Chicago time. These limits shall be in force for October 2010. Limits are as follows:
