## **S&P CNX Nifty Price Limits Effective for June 2012**

Price limits for S&P CNX Nifty index futures are revised to the following levels, effective as of commencement of Electronic Trading Hours (ETH) on Thursday, May 31, 2012, at 5:00 p.m. Chicago time. These limits shall be in force for June 2012. Limits are as follows:

## **June 2012 S&P CNX Nifty Stock Index Price Limits**

Contracts	10% up and down	15% up and down	20% up and down
E-mini S&P CNX Nifty	490.00	735.00	980.00
E-micro S&P CNX Nifty	490.00	735.00	980.00

Exchange Rules call for the limits to be re-calculated monthly at the close of business on the day preceding the commencement of a new calendar month. The contracts are listed by and subject to the rules of CME
